IOC's new strategic roadmap to strengthen sports integrity

Earlier this month, the IOC Session adopted a new strategic roadmap, Olympic Agenda 2020+5, which consists of 15 new recommendations, building on the results of Olympic Agenda 2020. The recommendations will guide the work of the IOC and the Olympic Movement until 2025, and are based on key trends that have been identified as likely to be decisive in the post-coronavirus world. Amongst other things, they are aimed at expanding current efforts to prevent competition manipulation (recommendation 5) and strengthening the Olympic Movement through good governance (recommendation 14).
