Over 500 participants joined the fourth edition of the International Forum for Sports Integrity (IFSI), which was led by the IOC and held virtually on 9 November 2021. Representatives of the Olympic Movement, governments, intergovernmental agencies,

betting entities and other experts met to assess the achievements, benefits and challenges of the International Partnership Against Corruption in Sport (IPACS), discuss good governance and map out future action for preventing competition manipulation.

New UNODC-IOC guide

A new UNODC-IOC guide on “Legal Approaches to Tackling the Manipulation of Sports Competitions” aims to support governments in developing legislation in this important area. It provides law- and policymakers, prosecutors and other officials with practical approaches, best practices and guidance on how to help enhance the credibility and transparency of sport within their remit. The guide also proposes a model criminal provision that could be used by lawmakers to introduce a specific criminal offence on the topic.
