
WORLD SAILING





Guidelines regarding Authorised Identifications Olympic Games Paris 2024 · Sport-specific Guidelines

All General Principles apply unless expressly mentioned otherwise hereafter (in particular in relation to size, frequency or location). Please refer to the "Identifications on NOC Team Apparel Practical Guidelines", and General Guidelines (released Summer 2023) to obtain the general principles of Authorised Identifications on NOC uniforms at the Olympic Games. This section provides visual illustrations regarding the placement and size of Sport Specific Implementation for any items.

SUBMISSION PROCESS

No additional obligatory submission process required by World Sailing, section 14 of the General Guidelines applies.

ATHLETE FRONT

Identification of the Manufacturer

Clothing

 Jacket | Pants/Trousers | T-shirt/Shirt/Singlet/Vest One Identification of the Manufacturer [] per clothing item will be permitted, to a maximum size of 30cm².

Sport Equipment

- Personal floatation device One Identification of the Manufacturer [] per clothing item will be permitted, to a maximum size of 30cm².
- Trapeze | Harness | Helmet | Impact Vest May carry the Identification of the Manufacturer as generally used on products sold through the retail trade during the period of 6 months or more prior to the Games subject to the World Sailing Advertising Code which limit the frequency and location of the Identification of the Manufacturer. Helmet need "high visibility stickers" in accordance with the rules of the Olympic Sailing Competition, and are permitted to display national flag and be in the design of the NOC identity (ie colours).
- Sails | Boats Sail | Sail Bags | Boat Covers Sails may carry the Identification of the Manufacturer as generally used on products sold through the retail trade during the period of 6 months or more prior to the Games, subject to the World Sailing Advertising Code Regulations 20.4 and 20.7, which limit the frequency and location of the Identification of the Manufacturer.
- Toolboxes | Equipment boxes | Trailers | Trolleys | Other storage devices | Covers of all equipment No Identification of the Manufacturer will be permitted.

Accessories

Socks

One Identification of the Manufacturer [] will be permitted per item, to a maximum size of 10cm².

Headgear

One Identification of the Manufacturer will be permitted per item, to a maximum size of 10cm² or two Identifications of the Manufacturer, to a maximum size of 5cm² each, placed above each ear.

Towel

No Identification of the Manufacturer will be permitted.

Gloves

One Identification of the Manufacturer [] will be permitted per item, to a maximum size of 8cm².

May carry the Identification of the Manufacturer as generally used on products sold through the retail trade during the period of 6 months or more prior to the Games, with the Identifications permitted on the lenses so long as such identifications are tone-ontone, engraved into the lens, and is not deemed as conspicuous by the IOC.

Bag

One Identification of the Manufacturer per item will be permitted, not greater than 10% of the surface are of the item, to a maximum size of 60cm².

Shoes/Footwear

Shoes

All footwear items may carry the Identification of the Manufacturer as generally used on products sold through the retail trade during the period of 6 months or more prior to the Games.

Product Technology Identification

Clothing

 Jacket | Pants/Trousers | T-shirt/Shirt/ Singlet/Vest | Life jacket | Impact vest One additional Product Technology Identification [•] will be permitted per clothing item with a maximum size of 10cm².

NOC Emblem and National Identity

Additional IF Specifications

Section 05

Third Party Identifications (athlete names)

No names of athletes allowed on items, section 05 of the General Guidelines applies.

Section 07

NOC Emblems and National Identity

NOC flags, codes and names, and athlete names, which are supplied by the OCOG, shall be applied to the Equipment used in each Event as per the rules of the Olympic Sailing Competition as set out in the Notice of Race and other related documents.

National flags, which are supplied by the OCOG, shall be applied to the ILCA 7, ILCA 6, 470, 49er, 49erFX. iQFOiL, IKA-Formula Kite and Nacra 17 equipment - as per the Equipment Regulations for the Olympic Sailing Competition.

Helmets are permitted to display the national flag and national Identifications of the athlete [•] as per the rules of the Olympic Sailing Competition as set out in the Notice of Race and other related documents.

Additional IF Specifications

Section 09

Homologation Marks

Athlete supplied Equipment sailed in each Event shall display World Sailing plaques in accordance with Class Rules and World Sailing requirements.

A World Sailing In-house Certification mark shall be displayed if the certified in accordance with the World Sailing In-house certification scheme.

Clothing, personal equipment and safety equipment shall be in accordance with the Rules of the Olympic Sailing Competition as set out in the Notice of Race and other related documents.

470, 49er, 49er FX and Nacra 17 boats shall display World Sailing plaques in accordance with Class Rules and World Sailing requirements.

For the 470 sail, a World Sailing In-house Certification sticker shall be displayed if certified in accordance with the World Sailing In-house certification scheme.
